SNAP-ED PROGRAM OVERVIEW

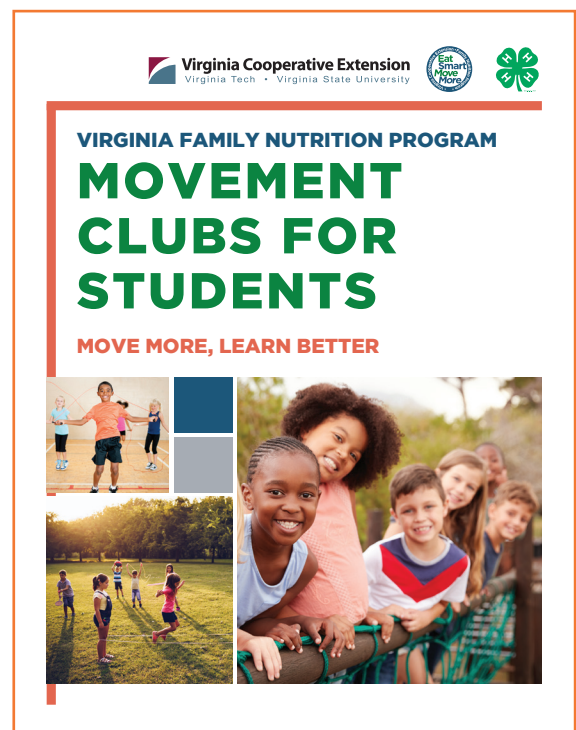


The first quarter of FY2022 for Virginia SNAP-Ed was marked mostly by online trainings and updates to support the ongoing delivery of programs.

Movement Clubs

In order to encourage movement and physical activity within schools (learn settings), a handbook/guide was developed for SNAP-Ed Agents to help train and facilitate school staff and volunteers on creating and/or adapting existing clubs into movement clubs for youth. The Movement Club handbook is a comprehensive tool for planning, implementing, and evaluating Movement Clubs and covers volunteer recruitment, session planning, risk management, parent engagement, and community outreach. It was pilot-tested this fall in Page County. Feedback from the pilot-test will help further refine the handbook in order to scale up to reach more SNAP-Ed eligible schools.
